# DHH \$61 million settlement largest in Missouri in 2017; Heidemann, Duncan recognized

A national class action settlement in a case filed by Douglas, Haun

and Heidemann, P.C. (DHH) against L-3 Communications, one of the largest defense contractors in the United States, has been ranked the largest reported settlement in Missouri for 2017. Attorneys Craig Heidemann and Nathan Duncan filed the case on behalf of Andrew Foster in December 2015 and the final settlement was approved in July 2017, resulting in more

than \$61 million in refunds including \$10 million in attorney fees paid by L-3 Communications. As a result of the settlement, more than 78,000 owners of the company's EOTech holographic


